SYSTEM CERTIFICATIONS

The support to the RUP is aimed at making a third-party contribution for complex procurement procedures in the field of Civil-Construction-Environmental Engineering and Industrial Plant Engineering works. The support is at 360 ° depending on the needs that may involve: the entire process of a public contract FROM THE DESIGN TO THE IMPLEMENTATION OF THE WORK, the SPECIFIC management of the contract with BIM technologies, the investigation and structural diagnostics.

TECHNICAL CONTROL ON SITE

Technical control on site for insurance purposes, to identify or avoid non-conformities and defects in the work, thus facilitating obtaining the ten-year posthumous policy.

OTHER SUPPORT SERVICES TO CONSTRUCTION COMPANIES

Feasibility assessment, design verification and supervision in order to avoid disputes and delivery delays through effective cost forecasting, supervision and design verification. SYSTEM CERTIFICATIONS

STRUCTURAL DIANOSTICS
