

CURRICULUM VITAE OF GIANCARLO VILELLA

Giancarlo Vilella, born in Brindisi (Italy) on 21 July 1955, is a **Civil Servant of the European Parliament - Director General of DG ITEC**

Since 2009: Lecturer of European Law at Università Politecnica delle Marche (Ancona, I) and since 2017 of E-Democracy at University of Milan (Milano, I).

EUROPEAN PARLIAMENT EXPERIENCE

1. Since April 2011: Director General of DG ITEC. In his capacity of DG he is responsible for information and communication technology services as well as printing and distribution services. His task is to implement Parliament's policy of transparency and access to information and helps Parliament to work more efficiently, by developing an innovation strategy and ensuring security. (2013/15: President of the Inter-institutional Committee for Informatics – 2014/17: President of the Publications Office Steering Board)
2. July 2009-April 2011: Director of Directorate for Publishing (in DG ITEC). In his capacity of Director he was responsible for the internal communication via Intranet, the edition of all EP official documents and their distribution within the decision process, the relationships with the OPOCE.
3. From September 2004 to June 2009: Head of Human Resources Unit in the Socialist Group (PSE) to which he was seconded. This role implied the management of 220 people and the responsibility of a considerable amount of financial resources. From September 2004 to September 2006 he was also in charge of the EP Bureau work.
4. From April 2002 to August 2004: Advisor Manager of the Secretary General of the PES Group. This role required the co-ordination of the secretariat structures of the Group and implied direct responsibilities with regards to the organisation of the Group's activities, to the decisions taken and their implementation, to the internal and external relationships, and to the strategic perspectives of the organisation.
5. He has covered the work of the **Committee for Economic and Monetary Affairs** (1990-93), the **Monetary Sub-committee** (1993-95) and the **Committee for Regional Policy** (1995-98).

INTERNATIONAL MANAGEMENT EXPERIENCE

6. From 1999 to 2001: **Director General of the International Institute of Administrative Sciences**, an organisation where more than 100 countries are represented. As Director General he was in charge of: the organisation and implementation of international colloquia, seminars and working groups; the organisation and implementation of statutory committees meetings; the publication of books and the International Review of Administrative Sciences; the achievement of partnership researches (namely with UNO and UNESCO); management of staff and financial resources. As Director General he was called several times (in the different continents) to give his advice as an international expert as well as specialized speeches on public administration.
7. From December 2000 to December 2002: **member of the Executive Committee of the International Social Sciences Council**, an institution representing inside UNESCO all the international organisations in the fields of social sciences.

OTHER ADMINISTRATION EXPERIENCE

8. From 1980 to 1990, he was a **member of the Regional Control Committee on the Acts of the local Administrations** of the Marche (Italy). This is an administrative body with the **power to approve or to annul the administrative decisions** of the Counties and of the local health and transport Authorities. All public functions were under this control, including budget and public services management.

EDUCATION AND ACADEMIC EXPERIENCE

9. Since 2009: **Lecturer of European Law** at Università Politecnica delle Marche (**Ancona, I**), and since 2017 of **E-Democracy** in University of Milan (**I**).
10. In 1974-78: studies at the University of Urbino, where he was awarded a Graduate degree (Laurea) in **Political Sciences**, with "public administration" specialisation (**summa cum laude**). During his period as a university student, he was President of the Colleges' Cultural Initiative Centre, as well as President of the University Cultural Centre.
11. In 1979: researcher holding a **Banca d'Italia scholarship** (Central Bank of Italy): he analysed the relations between banks and regions.
12. In 1980 - 1981: **researcher of the National Research Centre (CNR)** at the University of Perugia, where he specialised in problems of economic law.
13. In 1981: appointed "**permanent senior researcher**" at the **University of Ancona (I)**, Faculty of Economics. As a university researcher, he had

responsibility for lecturing, holding seminars and tutoring for the courses of administrative law, economy public law and institutions of public law. He has also been **Assistant of the Legal Institute Director**, dealing with Institute's management.

14. From 1981 to 1990:

- **several study and research periods abroad:** at the RIPA in London (1983), EEC in Brussels (1984 and 1985), Squire Law Library of Cambridge (1985), European Council in Strasbourg (1986), ENA in Paris (1987) and LIPAM in Liverpool (1989).
- member of various **national research working groups:** ISAP of Milan, CINSEDO of Rome, CIRIEC of Milan, SSPA of Rome, FORMEZ of Naples (where he also taught).

15. From academic year 1991 to 2009: Lecturer at Universities of **Brussels (B)**, **Urbino (I)**, **Florence (I)**, **Nantes (F)**, **Kehl (D)**, **Pavia (I)**.
