STUDY PLANS A.Y. 2023/24 MASTER'S DEGREE COURSES – DM 270/04

How to submit the study plan:

The study plan must be submitted online, from your ESSE3Web reserved area: click on "STUDY PLAN > CAREER PLAN". Before submitting the PLAN, please read the information below.

- CAREFULLY read the **advice for the presentation of the study plan**, published on the pages of the Faculty website relating to your degree course <https://www.econ.univpm.it/offerta-formativa>;
- The choice of course teachings **must be made for all the years of the course and for all the shortlists of choice offered**;
- **Internship**: the student can include only one internship in the study plan; It is possible to add an international internship if linked to a mobility program.
- At the end of the online procedure, **the plan must be confirmed** and it will no longer be possible to make changes (for any problems, please contact the Student Secretariat). It is recommended to print the study plan which must be "**APPROVED**";
- The plan submitted online, confirmed and complying with all the rules (APPROVED) will be included in the student's career and it will be possible to book for exams;
- **After the deadline** for submission/modification of study plans, it will be possible to modify the plan by means of a specific request to the Student Secretariat and payment of the late payment of 50 euros.

1st year FUORI CORSO (full time e part time)	Students can modify the study plan limited to the choices already made. The change is possible only for courses activated in the current academic year with the same characteristics (name – SSD – credits) and in compliance with the rules set out in the degree programme. Master's Degree in Economia e Management (changes to the plan for 1st and 2nd year subjects)
 For AFC (634) and Marketing (635) tracks, enrolled in 22/23: the course **Decision Theory is not offered in 23/24, so it cannot be selected in the revision of the group 6 credits of your choice (statistical-mathematical field) of the first year.**

Master's Degree in Scienze Economiche e Finanziarie (changes to the plan for 1st and 2nd year subjects)
 Please note: from the year 2023/24 the course of study has been changed and only two curricula have been activated: **Financial Analyst (640) and Finance and Quantitative Methods for Economics (644)**

For the **Finance and Quantitative Methods for Business track, enrolled in 23/24:**
 The subjects of the 18 elective credits of the second year have been grouped into two sub-groups "Research" and "Intermediaries": these are indications that are provided to the student in the compilation of the plan depending on whether he wants to deepen one of the two areas. It is not mandatory to choose subjects within a single sub-group.

For the Banks and Markets track (639):

• **Students enrolled in the 2022/23 academic year and those enrolled in 2021/22:**

- for the group of 6 credits to be chosen - economics of the first year, the subjects Macroeconomia (advanced course 1 module) Financial Economics and International Economics will not be revisable - as they are not offered;
- for the group of 6 credits chosen from the first year, business field, the course of Finanza comportamentale will not be offered in 23/24;
- for the 9 CFU group chosen in the first year, it will be possible to choose only Economia finanziaria for the revision.

Enrolled in the FUORI CORSO for several years

They can modify the study plan limited to the courses activated in the current academic year with the same characteristics (name – SSD – credits) by submitting the plan in **paper form** that will be submitted to the Faculty Council for approval (N.B. registration in individual careers will take place after approval).

PART-TIME students (online procedure)

PART-TIME students can modify their plan in compliance with the rules. If they encounter any difficulties, they must contact the Student Administration Office to modify their Study Plan.
