#### Treatment of personal data:

#### Internship carried out in EU countries

Pursuant to and for the purposes of EU Regulation 2016/679 (GDPR), containing the General Data Protection Regulation, and, as applicable, of Legislative Decree 196/2003 (Personal Data Code), the parties lend consent to the processing of their personal data and they mutually acknowledge that personal data will be processed exclusively for the execution of all operations and activities related to this project.

The University and the Host, within the scope of their autonomy, maintain their respective status as independent data controllers, pursuant to art. 24 of the GDPR, and to this end, undertake, each as far as it is within its competence and under its own exclusive responsibility, to ensure that the processing of personal data collected and / or obtained for the purpose of carrying out this project, within the pursuit of its institutional purposes, are carried out in compliance with the provisions of the GDPR, including the fulfillment of the disclosure obligations, towards the interested parties and the adoption of methods that protect confidentiality, integrity and availability of the personal data being processed. The data will be kept for the entire duration of the project itself and subsequently within the terms provided for the ordinary prescription.

#### Internship carried out in non-EU countries
